# What motivated you to run for the Board of Education, and how does your background prepare you for this role?

I was motivated to run for the Westerville Board of Education because I believe every child in our district deserves access to an excellent, well-resourced public education - regardless of the language they speak, where they are from and what their zip code is. As a parent of three children who currently attend Westerville schools, I've seen firsthand the incredible dedication of our teachers and staff, as well as the challenges they face in meeting diverse student needs in the midst of limited funding and changing enrollment.

My background uniquely prepares me for this role. I'm a small business owner with close to 20 years of experience in budgeting, strategic planning, and community engagement. I've built partnerships that connect local resources to support schools, and I understand how to make fiscally responsible decisions while investing in long-term success. I've also been deeply involved as a volunteer in our schools, giving me insight into what works, where we can improve, and how to bring together parents, educators, and community members to create solutions. Serving on the Board is about listening, collaborating, and leading with transparency—and I'm ready to bring those skills to work for our students, staff, and community.

How will you ensure the Board maintains open and effective communication with parents, staff, and students?

Open, transparent, and consistent communication is essential for building trust between the Board, families, staff, and students. I would work to ensure that we are using multiple communication channels — not everyone engages the same way, so we need regular updates through email, social media, website postings, in-person meetings, and even student-led forums. Being a busy parent, I understand the challenges of all of the communication that we deal with on a regular basis, and the need for more ways than a one size fits all approach. I would engage in two way dialogue and active listening to ensure we are gaining clarity from staff, parents and community members. I would work to ensure we are looping back after a decision to ensure transparency. By making communication timely, accessible, and reciprocal, we ensure everyone feels informed, respected, and heard—strengthening trust and collaboration across the district.

# What strategies can or should our district implement to improve early literacy rates among struggling students?

Improving early literacy is about starting early, identifying needs quickly, and providing targeted and consistent support. I would advocate for early intervention, utilizing science-based screeners in Pre-K, Kindergarten, and 1st grade to quickly spot reading challenges and implement small-group or one-on-one interventions without delay. I would advocate to ensure all K-3 teachers have access to high-quality, science-of-reading-aligned materials and professional development, including strategies for supporting English language learners and students with dyslexia. I also believe the more we can engage parents and help to work out obstacles that they may feel hinder their ability to support their child, the better. I would work to seek out partnerships (I hope to secure and solidify business partnerships within the community) that could help to provide parents with tools, workshops, and take-home materials so literacy practice continues beyond the classroom.

# What motivated you to run for the Board of Education, and how does your background prepare you for this role?

I am running as the incumbent appointed Vice President of the Westerville City Schools Board of Education. With roughly 63% of our students being disadvantaged pupils, I know first hand what kinds of wrap-around support they need. I bring years of experience supporting youth in public & private projects. My background has helped me hone in on important skills such as communication and overseeing district finances.

# How will you ensure the Board maintains open and effective communication with parents, staff, and students?

To ensure the Board maintains open and effective communication with parents, staff, and students, I will focus on increasing board member outreach and engagement efforts districtwide. As Vice President of the school board, I plan to host quarterly meetings that include key district personnel who can address questions and collect feedback. Additionally, I will continue the "Around the Table with Anisa Liban" listening series, launched this summer, which aims to bring together parents, staff, students, and educators.

To facilitate effective communication, I will advocate for access to language services and critical resources for parents. I believe it's essential that every available resource is allocated to ensure access to these vital services. I recognize that many caregivers and parents may face challenges such as the digital divide, transportation issues, and language barriers. Therefore, it's crucial to make technological updates such as adding an easy to use contact form to the website and holding meetings that allow me to listen and relay important information from the district in collaboration with district leaders.

Furthermore, I will prioritize ongoing connections with the Westerville Education Association, the Parent Council, and building staff—not only when issues arise but also on a regular basis. This consistent communication will help us stay aligned and responsive to the needs of our community.

# What strategies can or should our district implement to improve early literacy rates among struggling students?

Improving early literacy rates among struggling students is crucial for their academic success and overall development. While our district currently aligns with state standards and the Third Grade Reading Guarantee, I believe we can adopt additional strategies to enhance our efforts.

First, I believe we should broaden our literacy instruction by incorporating various evidence-based practices. Expanding our network of external partnerships can provide essential support for students and their families, ensuring that children remain engaged and motivated in their education.

Additionally, I believe leveraging local colleges and universities can create opportunities for students to access diverse literacy programs. Hosting workshops and reading camps at public libraries during school breaks can offer a stimulating and enjoyable environment, helping to instill a love for learning in our students. Implementing mentorship initiatives, such as a "Reading Buddy" program, can further encourage reading by pairing younger students with older peers or community volunteers, fostering both support and enthusiasm for literacy.

I also believe that integrating technology-assisted learning tools tailored to individual reading levels can enhance literacy instruction. These adaptive programs offer immediate feedback, making them particularly beneficial for struggling readers, including English language learners and students with disabilities.

Investing in professional development for teachers is essential, as it equips them with the latest research and strategies in literacy instruction. I believe this empowers educators to better meet their students' diverse needs.

Finally, I believe that regular assessments to monitor literacy progress will enable us to refine our interventions and ensure that we are effectively addressing the challenges our students face. # What motivated you to run for the Board of Education, and how does your background prepare you for this role?

# How will you ensure the Board maintains open and effective communication with parents, staff, and students?

Open and effective communication is essential to a strong school district, and as a Board Member I've worked to build trust by listening, being transparent, and keeping families, staff,

and students informed. I believe communication must be a two-way street—where the Board not only shares information clearly, but also actively listens to the voices of those we serve.

To do this, I will continue to support multiple channels for communication, from in-person meetings, phone calls, surveys, and listening sessions to digital platforms that make information more accessible. Parents, staff, and students should never feel left in the dark about Board decisions or district priorities. I also believe in making Board policies and financial decisions as transparent and easy to understand as possible, so that everyone knows how resources are being used to support students.

Equally important is creating space for meaningful feedback. When our families raise concerns, when our educators share their expertise, or when our students and families speak about their experiences, those perspectives must help shape how we move forward. That's why I've consistently engaged with community members and will continue to do so, advocated at the Statehouse with their voices in mind, and pushed for programs—like expanded counseling services, social-emotional programming, processes that support recruiting staff that represent the diversity of our buildings, and resources to support our special education and English Learners staff—that reflect our shared priorities.

Strong communication is about more than updates—it's about building a culture of trust and collaboration. If re-elected, I will continue to make sure every parent, staff member, and student feels heard, valued, and informed, and that their voices are part of shaping the future of our schools.

# What strategies can or should our district implement to improve early literacy rates among struggling students?

Helping every child become a confident reader is one of the most important responsibilities of our schools, and it is also one of the most complex. When we look at our district's report card, our early literacy rates are similar to districts like ours - Pickerington, Gahanna-Jefferson, Hilliard, and Worthington. But these numbers don't tell the full story. Factors such as families moving in and out of the district, the number of English Learners, and frequent changes to state standards all affect results. And while many children can read words in the early grades, true literacy requires comprehension—the ability to make meaning from those words and apply them in real life.

That is why we must stay focused on both strong instruction and targeted support. The expansion of the Multi-Tiered System of Supports (MTSS) is an important step. MTSS gives us a way to identify student needs early, provide the right level of support, and monitor progress over time. This means a struggling reader can get help right away—whether through small group instruction, specialized reading intervention, or additional language support.

Equally important is ensuring that all students are taught with a high-quality, research-based curriculum. Expanding Wit & Wisdom into kindergarten through second grade provides teachers with a framework that not only teaches students how to read but also builds their

knowledge and comprehension skills. When combined with the expertise of staff such as reading specialists, intervention teachers, special education, and English Learner staff, this creates a powerful network of support to meet students where they are and help them grow.

By pairing research-based curriculum with a strong support system like MTSS, our district can give every child the tools they need to thrive. Investing in early literacy is investing in the future success of our students—and our community.
